State Department of Education, School Finance	Julie, Pam, Brandon & Tim Hill	School finance review of IFARMS, Tuition, SBM, Indirect costs, Calendars, Attendance, Budgets, Bond Levies, Buildings, Salary & Benefit Apportionment and an Overview of the State Funding Formula.
Transportation Financial Reporting	Alexandra McCann, SDE	A review of state transportation annual reporting and filing of reimbursement requests. Additional examples of proper filing of annual reports will be shared and discussed. The first half of the presentation will focus on owner/operator districts and the second half will focus on contracted districts.
Drivers Education - Forms and Procedures	Audra Urie SDE	A review of drivers education reporting with guidance on forms and procedures to maximize the program in your district.
